- ☐ Has a great deal of energy and enthusiasm and will be able to participate in our monthly meetings, programs, and committees
- ☐ Is willing to work on and chair Chamber projects, such as the *Golf Tournaments, Christmas Parade, Membership Celebration, etc.*, and
- ☐ Has been an active member of TACC for at least one year.

TACC Directors are eligible to serve no more than two consecutive three-year terms.
